Summary: The Community Impact Director, Financial Stability oversees and implements UWMC's asset building and affordable housing programs through partnerships, grant making, direct service, and advocacy. Our goal is for Monterey residents to be economically self-sufficient, with more opportunities for prosperity. These programs and services are supported by grants from foundations, government contracts, corporate and individual donors.

CalWORKS Community Service Program

- Provides administrative oversight and management support for the Community Impact Coordinator.
- Oversees program reporting and ensures contract renewal
- Provides budget oversight to ensure timely and effective use of funds

- Implementing continuous improvement in volunteer engagement with surveys, communication, and strong organizational supports
- Marketing, outreach and recruits existing and new volunteers
- Supporting team to attend Saturday tax law training sessions October through January, provide snacks and materials, and track volunteer progress while providing support for success
- Supporting program and volunteers to implement VITA program February through April providing snacks and materials, providing support for success of Site Coordinators and volunteer tax preparers

 Oversees grant funded partner to ensure contract compliance, emergency food and shelter and financial capacity building programming

Asset Building Initiatives

Actively engages in community initiatives that support affordable housing and asset building

Emergency Rental Assistance Program (ERAP) and Housing Stability Grants

- Reports to the County Department of Social Services and the Federal Treasury on number of households served, and dollars spent
- Manages Neighborly software contracts, run reports, and analyze data to report to funders, board, and community
- Ensures timely spend-down of grant funds
- Reports to the State Department of Housing and Community Development on Emergency Rental and Utility Assistance dollars spent
- Financial oversight of dollars spent on Emergency Rental and Utility Assistance
