b. Presentation on Existing Data on Homeless students (K-12) in Monterey County Cynthia Nelson-Holmsky provided a brief introduction and history to the process to how this presentation was brought forth to the council. This data can be used to advocate for housing development keeping children in mind.

Michael Applegate from Bright Futures presented to the council on the existing data on homeless students in Monterey County. This helps shows homeless by zip code and regional level using school district data. The hope is this data will help with grant applications and advocacy around children who are homeless.

Dora McKean asked how data could be collected for children 0-5 not in the K-12 system to be included. Elsa Jimenez mentioned Health Department is working on it,

but has no solutions as of yet.

Darius Brown, Homeless Coordinator of MCOE provided additional content regarding student homelessness. School district use a different definition than health department or other organizations that can cause a lot of confusion. School districts use MV instead of homeless, because definition is broad and those who qualify may not even know it (or could be that survey at schools may not only not capture the eligibility factors for social supports, they also are not necessarily asking the same questions across schools and districts to determine eligibility)

Wendy Askew asked how council members could make sure people know that social supports are available for unaccompanied children under MV definition.
